# Suggestion:

#### Creation

We believe that God created all that exists, forming the physical universe over a period of six twenty-four hour days. The Creation account in the Bible is no allegory or figure of speech, but a true outline of God's activity in creation. God directly created all forms of life as fully functional unevolved

organisms, designing all to reproduce after its "kind" and allowing no

reproduction across "kinds" by God's established law. The creation record is

factual, historical, and clear; thus all theories of origins or development that involve evolution in any form are false. God sustains and orders all creation through his power and under his providential care.
